The Government of Sierra Leone has allocated funds to the National Medical Supplies Agency for the procurement of Pharmaceuticals for the Free Health Care Initiative, and now invites sealed bids from eligible bidders for the supply of the following products:

- Quinine DiHCl 300mg/ml, Injection, 2ml Amp

- Water for Injection 10ml, Amp
- Albendazole 400mg, Tablet
- Amoxicillin 250mg, Dispersible, Tablet
- Folic Acid 5mg, Tablet
- Metronidazole 250mg, Tablet
- Povidone Iodine 10%, Solution, 200ml Bottle
- Quinine Sulphate 300mg, Tablet
- Epinephrine HCl (Adrenaline) 1mg/ml, Injections, 1ml, Amp
- Ferrous Sulphate & Folic Acid 200mg & 0.4mg, Tablet
- Gentamicin 10mg/ml, 2ml, Injection

- Nystatin 100,000IU/ml, Suspension, 30ml, Bottles
- Vitamin A 100,000 IU (Blue), Capsules
- Zinc Sulphate 20mg, Dispersible, Tablets

Bidding is open to suppliers from all countries, and bidders shall not be under suspension for corrupt and or fraudulent practice. Bidders shall demonstrate compliance with All requirements in the bidding document.

Payment should be made into NMSA's Bank Account # (001-118002-03-0184) at the Sierra Leone Commercial Bank, Siaka Stevens Street, and pay-in slip submitted to the Finance and Procurement Units of the agency. The Bidding Document will be sent by courier on request to interested Bidders upon an additional payment of One Million Five Hundred Thousand Leones (SLLe 1,500,000.00) or its equivalent in any freely convertible currency. The Bidding Documents will be promptly dispatched by courier upon receipt of evidence of payment, but no liability can be accepted for loss or late delivery.

A "Pre-Bid Conference" would be held at 10.00 AM GMT on Friday 9th October 2020, at the Conference Room of the National Medical Supplies Agency at 31 Murray Town Road, Freetown. Provision would be made for virtual participation as well.

Completed serialized/paginated Bids must be delivered to the address below on or before Tuesday 27th October 2020 at 11:00 AM. All bids must be accompanied by:

- ☐ Bid Security of One Hundred and Twenty Million Leones (SL Le 120,000,000.00) from a reputable Bank or its equivalent in freely convertible currency;
- ☐ A valid updated tax certificate;
- ☐ A valid business registration;
- ☐ A valid Nassit Certificate (only for Bidders based in Sierra Leone);
- ☐ Three Years audited Financial report
- ☐ Evidence of experience in similar supplies
- ☐ A signed Integrity Pact

Bids will be publicly opened on Tuesday 27th October 2020 at 11:15 AM, in the presence of bidders' designated representatives (with written permission/authorization from Bidders), and any member of the public who chooses to attend at the address below. Late bids will be rejected and returned unopened to bidders.
